DOE F 5631.18 Security Acknowledgement	DOE form required of all DOE clearance applicants personally acknowledging their security responsibilities.
PD-DS 144 No-Fee Agreement	SNL form (issued by Procurement) required for all No Fee Consultants documenting an agreement between SNL and an Individual or company/firm (i.e., Service Provider) for services provided at no cost to SNL.
SF 2730-PRO NM Consultant Pre-Processing Background Review Form	SNL form required for all SNL/NM Consultant initial and reinstate (<i>if absent over one year</i>) clearance requests necessary to conduct a background review required by DOE regulations.
SF 2730-CBR CA Consultant Pre-Processing Background Review Form	SNL form required for all SNL/CA Consultant initial and reinstate (<i>if absent over one year</i>) clearance requests necessary to conduct a background review required by DOE regulations.
