


Understanding the NEPA Process

The National Nuclear Security Administration is preparing a Site-Wide Environmental Impact Statement (SWEIS) under the National **Environmental Policy Act (NEPA).**

> **NEPA requires federal agencies** to consider and disclose how their actions may impact the environment including natural, human (health and safety) and socioeconomic resources prior to making a decision.
