

1.4 Your SDR's Guidance

YOUR SDR'S GUIDANCE



YOU'LL BE CONTACTED BY YOUR SANDIA DELEGATED REPRESENTATIVE (SDR) WHEN IT'S TIME FOR YOU TO WORK ON-SITE

Do not come on-site until your SDR has given approval. You and the SDR will discuss these topics as applied to your work:

- **Review/evaluation of all work to reinforce and refresh information**
 - This is also to determine if the work scope and plan is altered by COVID-19 restrictions and necessary modifications to combine Activity Level Work (ALW) hazard controls with COVID-19 controls
- **Safety briefing/kick-off**
- **Workspace and schedule modifications** to limit proximity to others, which may include reassignment of workspace, adding physical barriers, altering work schedules and Personal Protective Equipment (PPE) use

1.5 COVID-19 Transmission

COVID-19 TRANSMISSION



WHILE ON-SITE, KEEP IN MIND HOW COVID-19 IS SPREAD

With each activity you do on-site, **remember** how COVID-19 is spread and **proactively** think how to avoid transmission of the virus.

1. PERSON-TO-PERSON

The virus is spread mainly person-to-person.

- ❖ It spreads between people who are in close contact with one another (*within about 6 feet*).
- ❖ Respiratory droplets are produced when an infected person coughs, sneezes or talks.
- ❖ These droplets can land in the mouths or noses of people nearby or possibly be inhaled into their lungs.
- ❖ Recent studies indicate that even people not showing COVID-19 symptoms can transmit the virus to others.

2. CONTAMINATED SURFACES OR OBJECTS

This isn't the main way the virus spreads, but we are still learning.

- ❖ It may be possible to get COVID-19 by touching a surface or object that has the virus on it and then touching their mouth, nose or eyes.

SANDIA'S LAYERED CONTROLS



HOW SANDIA IS KEEPING YOU SAFE

Sandia has implemented “**layered controls**” based on **CDC guidance to reduce the risk of COVID-19 infection and spread** during work on-site, as seen below:

Screen individuals to prevent entry of those who may be at risk of transmitting the virus (daily health screenings, on-site testing)

Manage work environment to support social distancing (limited density, adding barriers, alternating work schedules, etc.)


Mandatory face-mask wearing in all common areas and when within 6 feet of others indoors or outdoors

Rapid medical response/mitigation of a positive case (rapid testing, rapid notification, contact tracing, decontamination and quarantine/isolation)

Sandia empowering the workforce to adapt to the new norm by providing tools and education

PREPARATIONS FOR COMING ON-SITE



MONITORING YOUR HEALTH

To ensure Sandia can continue to meet its national security mission and minimize COVID-19 spread among the on-site population, **Sandia is implementing daily health screenings** on all individuals prior to entering any Sandia facility.

Each day prior to entering Sandia facilities, subcontractor employees:

- **With an SNLID or sandia.gov email** must fulfill the daily screening requirement via a mobile/desktop app or report to an in-person screening.
- **Without an SNLID or sandia.gov email** must report to an in-person screening location.

1.10 Online or Phone App: Sandia Health Check

PREPARATIONS FOR COMING ON-SITE



I. ONLINE OR PHONE APP: SANDIA HEALTH CHECK

(only for subcontractor employees with an SNLID or sandia.gov email)



The health check app can be utilized on personal devices.

Using the [online or downloaded-phone app](#), you'll:

- Provide answers to **COVID-19 health screening-questions** before accessing Sandia facilities. Only medical staff will have access to the personal information you enter in the app.
- The app will then provide either:



Clearance for you to access on-site Sandia facilities

OR



Instructions for you to stay home and monitor symptoms or contact Medical immediately

1.11 In-Person Screening

2. IN-PERSON SCREENING



You can use this option at [specific Sandia locations](#) and then continue on to your workspace:

- Medical screeners will ask you **COVID-19 health screening-questions**. Only medical staff will have access to your personal information.
- The screener will then provide you instruction:

GO

Clearance for you to access on-site Sandia facilities

OR

STOP

Sent home to monitor symptoms or contact Medical immediately

1.12 Sandia Health Surveillance System

PREPARATIONS FOR COMING ON-SITE



SANDIA HEALTH SURVEILLANCE SYSTEM

Anyone with a **positive COVID-19 symptom screening** will be denied access to any Sandia facility.

Refusal to take part in daily health screenings will result in being denied access to any Sandia facility.

As a reminder, Sandia's subcontractors and their employees are **not to enter any Sandia facilities if they are ill or exhibiting any COVID-19 symptoms.**

1.13 Contact Sandia Medical If...

PREPARATIONS FOR COMING ON-SITE



CONTACT SANDIA MEDICAL AT (505) 284-4700 IF ANY OF THE FOLLOWING APPLY:

- You have been tested for COVID-19 and received a positive test result.
- You are being tested for COVID-19 and are awaiting test results.
- You were told by your personal healthcare provider that you may have COVID-19 based on your symptoms but were not tested.



- You share a residence with someone who has been told by their personal healthcare provider that they have or may have COVID-19, either by testing or symptoms alone (*household contacts of individuals with COVID-19 are at greater risk of contracting the virus*).

1.14 Protective Face-Covering Guidance

PREPARATIONS FOR COMING ON-SITE



PROTECTIVE FACE-COVERING GUIDANCE

Protect others – wear a face covering!

Face coverings (personal or employer-provided) are **required** to be worn at all times:

- **In all indoor common areas**
(such as conference rooms, shared cubicle areas, shared offices, break rooms, hallways, stairways, elevators, bathrooms, etc.)
- **When within 6-feet of others outdoors**

FURTHER SANDIA FACE-MASKING INFORMATION:

- **Surgical masks or cloth masks** must be worn when performing work within 6 feet of others.
- **Face coverings with exhalation valves are strictly prohibited** as these devices do not provide source control of the virus. Exhalation valves allow the user's breath to escape directly from the mask.
- Wearing a personal face mask for health reasons on Sandia premises **does not violate security protocol**, which has been recently revised.

1.15 Safeguards & Security Notices

PREPARATIONS FOR COMING ON-SITE



SAFEGUARDS & SECURITY NOTICES

- **Badge readers on Sandia buildings have now been activated for 24/7 operations**, rather than just evening and weekend hours. Since a PIN is not required, **no direct contact** with the readers is necessary. Swipe or present your badge to gain access.



- **Individuals are not allowed to 'vouch' others into pedestrian access control points**, such as doors, gates and turnstiles. All individuals must swipe or present his/her own badge at each access control point to enter buildings and secure areas.
- **Note that personal mobile devices cannot be taken into the Limited Area buildings.**

1.17 Protect Yourself and Others by Doing 4 Key Things

SAFE WORK PRACTICES ON-SITE



PROTECT YOURSELF AND OTHERS BY DOING 4 KEY THINGS

The four most important steps you can take to **minimize your risk of contracting or spreading COVID-19** in the workplace are simple:

Sick? Stay home -- or go home if sick at work!



Don't touch your face, especially eyes, nose & mouth!



Social distance by staying at least 6 feet away from others!



Wash your hands frequently with soap and water!

1.18 Tips to Safely Navigate Common Areas

SAFE WORK PRACTICES ON-SITE



TIPS TO SAFELY NAVIGATE COMMON AREAS:

- **Always take your face covering with you** as you move about during the day.
- **Drive separate vehicles**, but if that's not an option, then everyone in the vehicle shall wear a face covering.
- **Wait for an empty elevator or take the stairs.**
- **Close the door** while working in your office.
- **In restrooms, stand back and wait** to use the sink until others finish.
- **For small rooms, wait** until anyone occupying the room has left before entering.

IF YOU ABSOLUTELY MUST MEET IN-PERSON, REMEMBER CONFERENCE ROOM PROTOCOLS:

- **Limit in-person meetings** to only those that cannot be held by other means (*offer a Skype option for others*).



- **Maintain 6-feet of separation** between attendees and also wear face coverings.
- **Conference room capacity will be significantly lower** than before the pandemic (*~25% of normal*).
- **Recommend limiting meeting times** to no more than an hour. If more time is required, then 10-15 minute breaks should be taken hourly to help with face-covering fatigue.
- **Use only your own** pens and dry-erase markers. Limit keyboard use to 1 person.
- **Discourage paper handouts and eating** during the meeting.
- **Wipe down** high-touch surfaces between uses, if supplies are available.




